Large crowds are anticipated, as visitors will drive into our area from outside the totality zone for this event.

- Electric hookups will be available

- A copy of your 2024 Food Service License & Certificate of Liability Insurance must be sent with payment
- Checks should be made payable to Geauga Agricultural Society
