

GEAUGA PARK DISTRICT'S 2024 FAMILY FUN GIVEAWAY

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Promotion Description:** Geauga Park District's 2024 Family Fun Giveaway ("Giveaway") begins on Wednesday, May 1, 2024, at 10:00 AM (EST) and ends on Monday, June 3, 2024, at 10:00 AM (EST) (the "Promotion Period"). By participating in the Giveaway, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Geauga Park District ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Giveaway.
- 2. Eligibility:** Open to residents of Geauga County, Ohio, who are 18 years or older. Void where prohibited or restricted by law. Sponsor and its respective officers, directors and employees, and members of their immediate families and/or persons living in the same household as such persons, are ineligible to enter the Giveaway or win a prize.
- 3. Entry:** No purchase required to enter or win. Entry may occur online or on an official paper form. To enter, entrants must complete and submit a brief survey collecting first and last name, address, phone number, email address and a choice of interests. Entrants submitting invalid or illegible email addresses will be disqualified. Submitting this survey automatically subscribes entrants to periodic email notices from Geauga Park District regarding updates and activities in the parks. To be eligible to win, entrants must remain subscribed for the length of the Promotion Period. Entry into any previous giveaway does not disqualify entrants from this giveaway, but a new survey must be completed and submitted in order to enter.
- 4. Winner Selection:** Three winners of the Giveaway will be selected in a random drawing from among all eligible entries received throughout the Promotion Period. The random drawing will be conducted the week of Monday, June 3, 2024, by Sponsor or its designated representative, whose decisions are final. Odds of winning will vary depending on the number of eligible entries received. Potential winners will be notified by phone after the random drawing and must accept the Prize as directed by Sponsor within seven (7) business days of notification unless an exception is otherwise agreed upon. Any winner notification not responded to or returned as undeliverable may result in Prize forfeiture. Winners may be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively "the Prize Claim Documents"), and pose for a photo upon Prize redemption. No substitution or transfer of a Prize is permitted except by Sponsor in its sole discretion.

ARV of each Prize is up to \$500 for the archery equipment plus \$48-80 for the additional arrows, to be provided at the discretion of Ohio Premier Archery depending on the type of bow being accommodated. Prize redemption must take place by October 31, 2024, or else Prize will be forfeited. Prize cannot be transferred, redeemed for cash or substituted by the winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute Prize of comparable or greater value if the Prize (or any portion thereof) is unavailable or cannot be awarded for any reason.
