- Fee refunds for facility reservations will only be issued if cancellation is at least 7 days prior to reservation date. **REFUNDS WILL NOT BE ISSUED UNDER 7 DAYS FOR RESERVATIONS – NO EXCEPTIONS.**
- All shelter/lodge reservations last from 8:30 AM to 11 PM.
- **Clean-up is mandatory for all lodge & shelter reservations.**
Reservation holder responsibilities: vacuuming (if applicable), sweeping, mopping, wiping down tables & counters, putting all trash in provided trash cans, excessive trash removal (see Veterans Legacy Woods guidelines for cleaning requirements), removal of decorations and all personal items.
Park staff responsibilities: restrooms, basic trash removal (except Veterans Legacy Woods).
Any reservations that require more than one hour of staff clean-up will be calculated/billed at an hourly rate of \$50 per hour per staff member.

Law Enforcement Staffing

- All reservations of 100+ people where alcohol is served are required to secure a law enforcement presence, and the reservation holder is responsible for securing that staffing. Please contact Gauga Park District's Ranger Department for assistance in scheduling law enforcement. Hourly rates vary by law enforcement agency.
